- Provide medical advice as Scheme Medical Adviser on the applicability of pension scheme criteria in individual cases. Work may include reviews of existing awards and appeals, in addition to injury benefit assessments.
- Utilise Medigold's internal medical records database and diary system to ensure that the clinical procedures are fulfilled.
- In general pensions work is system-based and remote with no direct contact with the pension scheme member, so Scheme Medical Advisers work from home.
- Liaise with Administrators/Team Leaders regarding both client and pension scheme member queries (with support from Senior Scheme Medical Advisers as appropriate).

- Knowledge of Outlook and Word is essential, Excel and PowerPoint desirable.













