

#### Draft Minutes of the SOM Annual General Meeting June 18<sup>th</sup> 2019 5.30-6.30pm, Bristol

Dr David McLoughlin welcomed everyone, and issued a reminder that only SOM members have voting rights.

### 1. Apologies for absence

Dr Tony Mawson requested apologies. Apologies were given on behalf of Dr Robin Cordell, Dr Paul Nicholson and Dr Adrian Massey.

# 2. Agree minutes of the 2018 AGM (in pack) and matters arising

The minutes of the last meeting were agreed.

There was a question from the floor asking if there should be a discount on membership for trainees and as to whether this is preventing some trainees from becoming SOM members. A response to this was that as a multidisciplinary organisation the existing fee structure aim for all members to equally contribute, but acknowledged that this issue would be reviewed again by the board. It was noted that medical trainees could join as associates.

### 3. President's report, and strategy 2020-23, - verbal (with slide presentation)

Dr David McLoughlin ran through SOM's three strategic aims:

- Increase multidisciplinary membership
- Raise regional, national and international profile of SOM
- SOM to be a cost effective and efficient organisation

Dr McLoughlin confirmed SOM membership had increased by 270 members through the year, that a GP special interest group had been created and that feedback from webinars has been very positive and will continue on a regular basis. He also thanked Dr Steve Nimmo for his work this year after taking over from John Hobson as the new editor of the Journal.

Dr McLoughlin stated that SOM continues to be a multidisciplinary organisation, raising the national and international profile through it's Patrons and other SOM stakeholders. As part of cost saving and efficiency measures SOM is moving back to St Andrew's place later in the year, saving up to £50k in the process.

Dr McLoughlin then continued to thank all SOM members, SOM board, SOM staff members and Nick Pahl, SOM CEO.

# 4. To receive the Trustees' Report and Financial Statements, SOM & SOM – Honorary Treasurer

Dr Mangala Patil-Mead (Honorary Treasurer) noted that the key feature of the 2018 statutory accounts was a £99k net deficit. Dr Patil-Mead explained that the key reasons for this were the anticipated change

in membership profile, lack of surplus from the SOM's Quality Assured Appraisal Scheme, a reduction in net advertising, increased costs in systems development and flat journal income.

Dr Patil-Mead went on to re-iterate that the society continues to maintain healthy reserves, aims to continue to attract and expand membership as part of the membership strategy, and has planned a more pro-active approach to revenue raising activity.

Dr Patil-Mead spoke about how the financial results this year has focused attention on the challenges ahead, with a sustained improvement in finances required to ensure the sustainability of the organisation. She and Dr McLoughlin remained confident that the combination of the planned move, scrutiny of staff costs and a re-negotiation of the OUP contract with increased profit share would go some way to reducing the overall deficit.

This was proposed and seconded and unanimously agreed.
