As an OH Physician, you will take a leadership role in the governance and development of service delivery and programmes, overseeing service quality to improve standards, drive capability development and ensure compliance. Overall, your aim is to make sure employee health risks, including occupational health risks are managed proactively, resulting in a healthy, engaged, and productive workforce.
