Although RPS is a Designated Body we have aligned with the FOM for re-validation purposes and you will be required to undergo an annual SOM QAAS. Which provides the appraisal process for the FOM in accordance with the GMC's Good Medical Practice and their requirements for 5 yearly re-validation and re-licensing of doctors. A positive re-validation recommendation from the FOM Responsible Officer (RO) is based on the e-portfolio (PReP) and a face-to-face professional SOM QAAS. You will be required to undertake regular CPD (personal, internal and external), multi-source



feedback etc to maintain your professional competency and Licence to Practise. This also includes successful engagement in the External RPS OP Audit led by an independent OP.
